

MEMORANDUM OF AGREEMENT

The Memorandum of Agreement ("MOA") dated 4 January 2018 is referred. Pursuant to the Clause 2.2 in the MOA, this separate Memorandum of Agreement ("Agreement") is made on the 4 day of January 2017

Between

Yogyakarta State University, Indonesia (YSU)

And

Infrastructure University Kuala Lumpur, Malaysia (IUKL)

The Parties are desirous of pursuing an academic cooperation in relation to the Faculty Exchange and Student Exchange Programme (as hereinafter defined) subject upon the terms and conditions as hereinafter appearing.

1. Faculty Exchange Programme

Measures will be taken to encourage and put into place mechanisms for the exchange of Faculty member to develop, where appropriate, relationships between IUKL and YSU.

- (i) Based on the requirements and needs of both parties, YSU and IUKL agree to exchange their staff in specific areas of study. The duration of the teaching stint can be discussed further.
- (ii) Both parties are responsible to take care of the lecturers' benefits and welfare on a reciprocal basis.

2. Student Exchange Programme

Subject to meeting relevant admissions criteria, IUKL and YSU agree to the following:

- (i) Student exchange Programme are included credit transferred and dual Degree.
- (ii) YSU will annually assign 2 students of distinction to continue study at IUKL for a period of ONE semester for credit transferred and ONE-TWO year for dual Degree.
- (iii) IUKL will exempt the students assigned by YSU to study at IUKL from the Academic Fees such as Tuition Fee, Processing Fee, International Student Administrative Fee, Library and Student Club. However, other costs such as flight

tickets, accommodation, living cost, Medical Examination, Medical Insurance and Visa Processing Fee and fee related to the services rendered to obtain a Single Entry Visa are to be borne by the students.

- (iv) On a reciprocal basis, IUKL, at its own discretion, shall assign 2 students to study at YSU annually for a period of ONE semester for credit transferred and ONE-TWO year for dual Degree.
- (v) YSU can annually assign self-sponsored students to study at IUKL for a period of one semester. All the self-sponsored students are required to pay IUKL the Tuition Fee, Registration Fee, Visa Processing Fee, Medical Examination, Medical Insurance, Other Fees which include Library and Student Club. However, if these students decide to continue and complete their study at IUKL, these students are required to pay full fees according to the fee structure charged to International Students. The students are also responsible for all other costs incurred, such as travelling cost, food and accommodation and miscellaneous costs.
- (vi) On English Language assessment, students are required to have a minimum IELTS score of 5.0 or TOEFL score of 453. However, IUKL reserves the right to require an assessment of a student's English Language proficiency where it is felt to be in the interest of the said student's ability to fully benefit from a particular course of study at IUKL. Students who fail to meet the English Language proficiency requirements are required to enroll for the Intensive English Programme at IUKL.

3. **Coordination**

Each institution shall appoint a coordinator for this Agreement and keep the other university informed of the name and address of that person.

4. **Duration of Agreement**

This Agreement shall be effective for **five (5) years** from the date signed and is to be renewed for a further five year period automatically unless one of the partners gives notice of termination not later than six months prior to the expiry of the agreement. The terms of this Agreement may be amended at any time subject to mutual written agreement by both parties.
